



We provide three ('3') different types, which are:

- o First Time Training: We provide special training for beginners seeking to try new things for the first time..

What Is Treatment?

We define 'Treatment' as something that is done to help with a health issue, health symptom, or health illness, such as medicine or surgery.

Our Treatment

Treatment is the action of providing medical care to a patient or condition to prevent, cure, or slow the progression of an illness or injury. It can also refer to the management of health care and related services by a health care provider.

With our treatment, patients can receive the right care or the right sexual release for their overall health or comfort. We strive in giving the best health care and sexual care to our visitors. 



Making The Best Out Of Your Experience

For every member that joins, we want to give you the best experience possible with our care and treatment. Treat yourself to our stimulation treatment for a more deeper and fun experience. We allow adult toys and other erotic devices to be present during your sessions.

Booking Notifications

We strongly advise you to keep your notification toggles set to 'On' after you book a session online with us, as you will be notified of your booked confirmation only once.

Booking Schedules

We strongly recommend that you set your very own booking schedules for updates and changes that may occur during your booked appointments. Make sure to document your booked schedules as often to keep you on the right track of what's going on.

Member Check In

Before our staff members conduct any service for any client, it is important that the client check in and check out using his/her electronic signature. This is used for member tracking and security purposes. Each member who refuses to check themselves in, will immediately terminate his/her booking without a chance to reschedule the session and subject to a cancelation fee. Challenging this fee shall not be permissible in any way of the member.

Booking Confirmation

After placing and completing an online order, we will reach out to contact such 'Play Member' based on the information provided. To save time and avoid future booking issues, it is important to wait patiently for booking confirmation. We may occasionally issue booking confirmation identification numbers to you with your order. Booking Conference Calls

Our staff members may require clients to complete a video call or voice call for their security. It is recommended by our company to have already downloaded the 'Zoom' application on your electronic devices. By doing this, can help to bypass further verification protocols.

Choosing The Right Staff Member

We strongly ask that all members choose staff members in accordance with our policies, rules, guidelines, etc, at all times. Example: For male members, would select a female staff member.

Trained Staff Members

Our Staff members are uniquely trained and fully equipped to provide the necessary treatment for you. We work well and communicate effectively with our clients to avoid complications. Whether you were injured, exhausted, troubled, or sexually frustrated, our staff members are here to help.

It is our goal to use the best recommended or top of the line tools on the market, in order to give you the comfort and care that you desire. Bring the stress and we'll take care of the rest.

Respecting Our Clients

it is part of every staff member's duty to respect their clients and their current households. No staff member is trained to destroy or damage anyone's household or current living situations. It is important that every client remain transparent with us concerning updates or changes in their situation to be eligible for rescheduling or to avoid dangerous situations.

Staff Member Rights

Our staff members will only provide and conduct services of our company, if it does not violate our company's policies, rules, guidelines, etc; neither provide or conduct services that is not listed or outside the services and business of **Erotic Night's In**® in any way. Such staff members will only accept bookings from members that are compliant toward our instructions.

Please understand that our staff members are not obligated to accept every booking made by paid customers. If such staff member strongly believes that he/she is uncomfortable to perform or is somewhat fearful in assisting you, or disturbed by your behavior, such staff member are entitled to either terminate or discontinue the booked services altogether without warning or notification to any paid customer regardless of membership.

When this occur, usually paid customers are not charged for cancelation of services made by staff members, but only before a booked session begins. Fees may be waived for eligible customers whose sessions were canceled for unknown reasons.

Client Gender Classification

If you're someone that identifies himself/herself differently outside our sex restrictions, other than being a 'Male or Female' under our company, such as: Transgender, transwoman, and others related to such classification of gender, then it is important that you notify the staff member right away of your identity so that such member may be able to assist you to the tight place to avoid booking cancelations with us.

What Are Non-Consensual Acts?

This include unlawful acts that are not permissible or consensual by an individual. An example of a non-consensual act can be easily identified as: Molestation or rape.

How To Handle Such Cases

If you are someone that is a victim of a non-consensual act, we strongly advise you to contact our customer care department right away to report such incident before contacting local authorities in your area.

False Accusations Of Non-consensual Acts

it is important for each member to understand, that **Erotic Night's In**® does not tolerate false claims of non-consensual acts in any way or form. All false claims that are reported or filed pertaining to any alleged incident that did not occur, will be pursued under law until remedies are paid in full. As a quick note, based on the services provided by **Erotic Night's In**® may often require the staff members to touch or massage sensitive places or areas on the body during certain treatment.

Reports

You may feel free to report incidents or feedback with us anytime. Reports filed may be submitted via email, via telephone, or via mail. It is highly recommended to send us physical evidence in relation to your incident reports.

Report Investigations

We may often conduct investigations 'At Will' pertaining to any member's participation. Our investigations are done accordingly to our rules, policies, procedures, etc. We may sometimes contact the victim if we feel that there is information missing or if we may need additional information to continue our investigations.

EROTIC NIGHT'S IN® POLICIES

These policies must be followed for every visitor and members alike at all times:

No Kids Policy:

We do not allow children under the age and over the age of eighteen ('18') years old to be present during your scheduled appointments.

No Unwanted Visitors Policy:

You are not authorized to allow unwanted visitors or unauthorized guests ('e.g. Family relatives, neighbors, friends, or other significant partner(s)') to be present during your scheduled appointments.

No Loosed Animals Policy:

It is important that you lock away or put away any loose animals in your possession. We recommend safe and strong animal cages alike, for the void of causing animal attacks. For service animals, we will need verification if asked.

Safe Sex And Raw Sex Policy:

For your protection, we strongly encourage you to practice safe sex at all times, as people can carry many infections and diseases that he/she may or may not be aware of. However, if you agree to engage in unprotected sex activities, make sure that you and our booked team member get tested together. In this way, you can stay safe and help avoid possible injuries or unintentional harm.

Unlawful Activities Prohibited:

It is your duty to understand that it is against the law to conduct or attempt to conduct any violations of our rules, policies, and other restrictions provided by the company; likewise it is against the law to commit any unlawful activities ('e.g. Offenses, breach of contract, etc'), such as: Robbery, theft, murder, false imprisonment, false information, infiltration, bribery, kidnapping, abduction, and other crimes not listed or specified herein. These prohibited acts are punishable by law, as all offenders will be persecuted under the governing laws of our company.

Surveillance Policy:

It is the right of our staff members to document and record their interactions with their clients at all times for your safety and your safety. We do not allow nor authorize any and all discreet or unauthorized recordings (i.e. Video caneras, voice recordings, photographs, spy equipment alike'). This act will not be tolerated whatsoever and is automatically considered a breach of your agreement.

Drug Activities Policy:

If you are someone that uses drugs, distribute drugs, or simply deal/sell drugs in any way, we may immediately discontinue or terminate your appointment altogether. Our team members are required to cancel, reschedule, and terminate your appointments if we believe that you are in violation of our rules, policie, etc, of our company. These incidents will be reported immediately to us; likewise, shall you report any team member that you witness using drugs, distributing drugs, or dealing/selling drugs in any way, with us right away.

Medical And Safety Protocols:

If you ever experience a medical crisis ('e.g. Overdose, seizures, heart failure, breathing issues, etc') or simply act violent in any nature, our team members is authorized to contact local authorities or other emergency agencies for their safety and the safety of yourself. If you are someone suffers from any allergies, please make sure to report your allergies to our customer service center via website: 'Contact Us' tab right away before you engage in any booking activities of our company for your safety and health reasons.

Time Restrictions Policy:

We strongly encourage you to be respective and considerate of other customers scheduled times and their appointments with our team members. If you require additional time, please do not hesitate to discuss this with your assigned team member.

False Gender Classification Policy:

Our team members are restricted from accepting bookings made by customers who attempt to defraud, impersonate, or submit false information. For example: men taking on the roles and identity of women, likewise, women taking on the roles and identity of men. This act will not be tolerated whatsoever.

Hygiene Policy:

Please be sure to wash yourself thoroughly, if possible, on the day of your booked appointments. We recommend to customers to try and use safe products that are antibacterial, antifungal, or completely organic in nature to avoid possible health issues. At any time, if we determine that a your hygiene is not up to par within our standards of hygiene requirements, our team members may discontinue, reschedule, or terminate your scheduled appointments altogether.

Violation Of Our Policies:


If our staff members believe that a customer is in violation of our policies, rules, etc, of our company in any way, it is their duty to report these issues right away with us. It is good that you understand our concerns and to help avoid issues, for the void of termination of your membership and membership benefits. Once an account has been terminated from our system, a customer may not be eligible to reapply again until further notice.

Payments And Billing:

We require payment to be made before any service is provided to a customer. Payments must be paid in full in order to complete any scheduled booking. We accept debit, credit, MasterCard, and American express. No personal checks. We may require booking deposits to help ensure legitimacy of the booked session. WHAT WE EXPECT?

We strongly expect all E-Pass members to abide by our rules, procedures, instructions, protocols, policies, bylaws, and terms of our company at all times for the void of mishapenings, pregnancy, injuries, harm, damages, liabilities, costs alike, at all times.

HOW DOES IT WORK?

In order to make a booking, all E-Pass members must access our E-Pass service page entitled 'E-Pass', then simply enter the required information needed to complete and schedule a booked service. Booking deposits will be required to maintain efficiency of member bookings until further notice.

BOOKING NOTIFICATIONS

It is important to set or toggle your device notifications 'ON' through your device's 'Notification' settings. By doing this, it can help E-Pass members to receive booking updates whether via SMS or via email. We recommend that the following actions to help avoid cancellations, suspensions, and termination of your E-Pass memberships:

- o Set booking reminders;
- o Write down your set booking dates and times;
- o Call, email, or send your booking staff member via SMS text messages, if anything in your current situation changes (SMS text message data rates may apply);

E-PASS MEMBERSHIP TERMINATION

Your E-Pass memberships are automatically subject to Erotic Night's In ® policies, rules, terms, ordinances, codes, procedures, bylaws, protocols, restrictions, etc, and can be terminated, cancelled, revoked, or suspended at any given time by it's authorized personnel(s). We may terminate your membership for any reason, if we believe:

- Your hygiene is not up to date according to our standards;
- If you are in violation of our company policies, rules, etc;
- If you attempt to sabotage or harm our business, not excluding our staff members, clients, visitors, third parties alike;
- If the address chosen for the client's place of service is rigged, too dangerous to enter, appear to be unsafe, or simply violate the rights of other individuals;

E-PASS MEMBERSHIP RENEWAL

All E-Pass memberships is subject to expire within a given expiration date. Your membership may be eligible for renewal if:

- Your account is in good standing;
- Your account does not have a past due balance;
- Your account does not violate our rules, policies, etc;

To renew your E-Pass membership, you may simply reapply online. No auto renewals are enabled.

E-PASS MEMBERSHIP USAGE

We require each E-Pass member to handle and use their memberships responsibly without attempting to defraud others and our team of staffs. Such E-Pass membership that are granted to eligible candidates, does not grant him/her any rights to violate our company terms, rules, policies, etc, nor does such E-Pass membership grant any of the following rights described below to any individual at any given time:

- Distribution rights
- Transfer rights
- Copyrights
- Property rights
- Ownership rights and others alike.

With addition to rights, no membership granted, gives any unauthorized users access to such approved member's benefits, accounts, etc. All unauthorized access and their usages are subject to civil fines no less than \$3,000.00 b for violation of our company rules, etc.

UPDATES AND CHANGES

Our company rules, policies, terms, provisions, procedures, restrictions, etc, are automatically subject to modifications and changes from time to time or 'At Will' by authorized staff members.

SAFETY OF OUR STAFF AND E-PASS MEMBERS

Our staffs safely and your safety is our one of our main priorities. To ensure our safety, your safety, and the safety of other people, please follow these key points below:

☆ Relationships Transparency

It is extremely important to be mindful of your current relationships (i.e. Marriage, friendship, family, platonic, etc!) status. If you are taken or in a relationship of any kind, please notify your partner(s) before booking a session. By avoiding to notify your partner(s) can ultimately be dangerous and fatal to those around you. Here are a few steps that you can take to help prevent divorce, infidelity, or break-ups:

- Talk to your partner(s) about how he/she would feel about having open sessions or about having open relationships. (If, for any reason that your partner(s) become suspicious, or agitated, or concerned, or annoyed, or disturbed, or worried about the idea, try not to avoid their reaction or opinions about your ideas, but rather be truthfully humble toward his/her feelings around very populated environments or populated areas [never alone];
- Involve your partner(s) in activities;
- Seek reassurance from your partner(s) rather than taking sudden actions on things;
- Make sure that you and your partner(s) establish a complete mutual agreement between you and him/her/them;
- Allow your partner(s) to understand the things that you are interested in trying (e.g. Our services, treatments, etc);

☆ Safe Environments

It is highly important to provide safe places or areas for booking and meeting purposes, when entering a address for client's place of booking. Do not include unsafe places or areas that would potentially put you and the life of our staffs in danger. If you are listing your primary residence as for client's place of booking, we will not provide services, if:

- You and your partner(s) or roommates live with eachother; or simply visits you at your primary residence;
- You have any rodents, insects, or parasites infestations;
- There are criminal activities at your booking locations or in the area from your booking location;
- There are any illegal drug-like activities and their dealings at your booking locations or in the area;
- There are any unwanted visitor's present or attempting to be present at your booking locations;
- There are any unlawful or non-consensual recordings, reportings, or unauthorized disclosures conducted;
- There are unlawful or illegal weapons present or attempting to be present at your booking locations;
- The environment is comprised with depictions of religious beliefs of war, harm, killings, and rituals alike, either in it's likeness thereof;

If the address that you've selected for client's 'Place Of Service' is a commercial business or at a commercial property, such as: Hotels, motels, etc, we expect you to:

- Follow all rules, policies, and procedures of the commercial business;
- Do not destroy or damage anything of the commercial property;
- Be respectful toward the business and it's guests at all times;

We expect you to be respectful of your areas and toward your partner(s) privacy rights. It is not the intentions of our staffs to break up relationships or marriage, in any way possible. If our staff members determine or believe that a area or situation is dangerous to him/her or believe that there are discrepancies in the information given, it is highly probable that your booking may be cancelled or terminated altogether without a renewal of benefits. We strongly advise you to keep your bookings privately to yourself at all times and unto no other person(s). By simply doing this, can help save lives, and can help to prevent or possibly lower the chances of injuries, harm, and damages alike, which may be incurred by the intentions of others, including your partner(s).

☆ Car Dates

For car dates (if applicable), we expect you to have your own personal vehicles for service. Make sure that your own personal vehicles are currently running, fairly maintained, and compliant with State law. We do not, under any circumstances, make purchases or provide gas for you.

☆ Safe Sex

We expect everyone to practice safe sex at all times. By practicing safe sex acts, can easily prevent or possibly lower the chances of pregnancy or contracting dangerous sexually transmitted diseases alike. If you are allergic to any safe sex products, please notify our staff members immediately before you engage in activities, so that we may find other reasonable solutions and less harmful alternatives for you.

Please follow the instructions and directions provided on each safe sex product that is available for any usage. Use such safe sex products responsibly and with absolute care. We want the best for you, so please try to encourage yourself and booking partner(s) to use such products correctly.

☆ Member Allergies

If you are someone that suffers from allergies or have allergic symptoms to any products being used for treatment, it is your responsibility to alert the assigned staff member right away or either send us an email describing the nature of your symptoms. Billing Policy:

o Billing Responsibility

o Transportation






